

## UCLA Travel Study COMMUNITY COMPACT

To help minimize potential exposure to infectious diseases within the local community abroad, all UCLA Travel Study students are required to agree to comply with the Community Compact that includes some terms that are in addition to, or different from the terms referenced in the <a href="Student Participation">Student Participation</a>
<a href="Agreement">Agreement</a> and <a href="Program Policy Agreement">Program Policy Agreement</a>. To the extent that the terms of the Community Compact are contrary to either agreement, the Compact shall prevail.

Recognizing the interdependence of all members of the UCLA Travel Study Program, my host country community, and my responsibilities as a UCLA student, I commit to assume personal responsibility to help protect others and ourselves by contributing in a way that will promote everyone's health and safety.

As a UCLA Travel Study Program participant, I understand and agree to all the following:

- I am committed to the health and safety of all and will do my part to limit the spread of infectious diseases by making my own health and safety, and that of others, a priority.
- I will remain mindful that actions I take can help limit the spread of infectious diseases to others in the local community, including the most vulnerable.
- I must comply with local public health guidelines and with program requirements regarding
  infectious disease prevention practices, including any <u>UCLA COVID-19 Protocols</u> that apply
  during the course of my program participation at UCLA. I understand that local public health
  guidelines may differ from my home UC Campus, the state of California, and the United States
  of America guidelines.
- I understand it is my responsibility to research local public health guidelines and consider my personal risk tolerance before participating in a UCLA program.
- I will adhere to relevant infectious disease requirements, including: masking, testing, practicing
  good personal hygiene/hand-washing, social distancing, and other strategies, if required by
  UCLA, the host university, and/or local public health directives, when participating in academic
  and cultural activities associated with my program.

## I understand that:

- I may be required to comply with additional mitigation measures in the future based on the program activities, on-site program partners, local government and/or UCLA issued health directives.
- Violations of these mitigations measures could put myself and others at risk for serious health complications.
- UCLA IEO and its on-site program partners are taking reasonable steps to mitigate risks to the program community, but that it is not possible to eliminate the chance of infection and associated health risks.



I may be required to leave the program immediately for not complying with any of the
provisions of this Compact, and that serious or persistent non-compliance may result in
suspension and/or corrective or disciplinary actions and sanctions under the procedures set
forth on the <u>UCLA Student Code of Conduct</u> and <u>UCLA COVID-19 Protocols</u>.

Although noncompliance can result in disciplinary sanctions, I recognize that UCLA IEO and its on-site program partners are relying on the voluntary actions of each of us as community members to do our part.
